**Announcement for Handling of Proofs of Rehabilitation Claims Filed After
Deadline**

The period for filing proofs of rehabilitation claims in the civil rehabilitation proceedings for MTGOX Co., Ltd (“**MTGOX**”) ended on October 22, 2018 (Japan time) (this civil rehabilitation proceedings: the “**Civil Rehabilitation Proceedings**”).

However, if filings are delayed for reasons not attributable to creditors, proofs of rehabilitation claims filed after the deadline (i.e., October 22, 2018) may be acceptable.

Whether proofs of rehabilitation claims filed after the deadline will be accepted is determined by the court. Considering that creditors in the Civil Rehabilitation Proceedings are located worldwide, and that a certain period of time is required for proofs of rehabilitation claim forms to be delivered, among other factors, the Rehabilitation Trustee will make efforts to request the court to accept proofs of rehabilitation claims received by December 26, 2018 (Japan time).

Accordingly, if you are a user of the MTGOX Bitcoin Exchange or other creditor of MTGOX and have not yet filed your proof of rehabilitation claim, **please ensure to file a proof of rehabilitation claim by December 26, 2018 (Japan time)**.

The online filing system for rehabilitation claims (<https://claims.mtgox.com/assets/index.html#/>) is still accessible. For creditors who are unable to use this system, please download a proof of rehabilitation claim form from the link below, fill in the necessary information thereon on your computer, and then send a printed version, on which you have affixed your seal or signature, to the Office of the Rehabilitation Trustee by post to the address below (the “**Offline Method**”). **Your filing must be delivered by no later than December 26, 2018 (Japan time)**.
