Notification of Approval or Disapproval on Exchange-Related Rehabilitation Claims

On March 15, 2019, the Rehabilitation Trustee filed with the Tokyo District Court a statement in which it approved or disapproved all or part of each rehabilitation claim filed by the MTGOX Bitcoin exchange users (the "<u>Users</u>") related to their rights to claim for return of cryptocurrency and/or cash against MTGOX (the "<u>Exchange-Related Rehabilitation Claim(s)</u>").

The Rehabilitation Trustee notified its approval or disapproval of the Exchange-Related Rehabilitation Claims to the Users who filed their Exchanged-Related Rehabilitation Claims by the following means:

1. Users Who Filed Exchange-Related Rehabilitation Claims Using the Online Filling System (the "System") (such Users; the "Online Users")

(1) Online Browsing

By logging into the System, the Online Users can:

- (i) check our approval or disapproval of their own filed claims online by clicking "VIEW RESULTS OF APPROVAL OR DISAPPROVAL OF REHABILITATION CLAIMS"; and
- (ii) browse the whole statement of our approval or disapproval (part of which will be redacted), which details each approval or disapproval for each Exchange-Related Rehabilitation Claim.

(2) Email Notification to Online Users
